SPEAKERS

Martin Phillipson, Dean, College of Law, University of Saskatchewan (LLB'89,LLM'91)

Martin Phillipson became dean of the University of Saskatchewan College of Law on July 1, 2016. He received his LLB from Leicester University in the UK in 1989, and his LLM from the University of Saskatchewan in 1991.

He joined the College of Law as a professor in 1999, having previously held faculty positions at Osgoode Hall Law School in Toronto, Victoria University of Wellington in New Zealand, and the Australian National University.

In addition to his work in the College of Law, Professor Phillipson has held several senior administrative positions at the University of Saskatchewan including several years as vice-provost of the College of Medicine where he led a major restructuring of Saskatchewan's only medical school. Professor Phillipson's teaching and research interests lie in the fields of Intellectual Property Law and Biotechnology Law with a particular focus on the law pertaining to GMO.

Maria Campbell, Cultural Advisor, College of Law, University of Saskatchewan

Maria Campbell received her honorary doctorates from the University of Regina in 1985, York University in 1992, and Athabasca University in 2000. She is a Métis author, playwright, broadcaster, filmmaker, and Elder. In addition to her work in the arts, Maria is a volunteer, activist and advocate for Indigenous rights and the rights of women. She was a founder of the first Women's Halfway House and the first Women and Children's Emergency Crisis Centre in Edmonton. Maria sits as an Elder on the Saskatchewan Aboriginal Justice Commission, and is a member of the Grandmothers for Justice Society

Elder Joseph Naytowhow, Knowledge Keeper

Joseph Naytowhow is a gifted Plains/Woodland Cree (nehiyaw) singer/songwriter, storyteller, and voice, stage and film actor from the Sturgeon Lake First Nation Band in Saskatchewan. As a child, Joseph was influenced by his grandfather's traditional and ceremonial chants as well as the sounds of the fiddle and guitar. Today he is renowned for his unique style of Cree/English storytelling, combined with original contemporary music and traditional First Nations drum and rattle songs.

An accomplished performer, Joseph is the recipient of the 2006 Canadian Aboriginal Music Award's Keeper of the Tradition Award and the 2005 Commemorative Medal for the Saskatchewan Centennial. In 2009, Joseph also received a Gemini Award for Best Individual or Ensemble Performance in an Animated Program or Series for his role in the Wapos Bay series. That same year he was also awarded Best Emerging Male Actor at the Winnipeg Aboriginal Film Festival for his role in Run: Broken Yet Brave and won Best Traditional Male Dancer at John Arcand's Fiddlefest in Saskatchewan. He has performed for the Prince of Wales, the Lieutenant Governor of Saskatchewan and many other notables. His demanding schedule continues to take him to conferences, symposia, forums, festivals and film sets across Canada, North America and around the world.

Fifteen years of study with a Buddhist master, combined with his Nehiyo/Cree traditional knowledge and his experience as an interdisciplinary artist, has nurtured Joseph's generosity and compassion for sharing cultural knowledge. He is a much sought after keynote speaker, counselor, and educator for children and adults alike. Joseph frequently enjoys opportunities to work as a resident artist and cultural advisor for various organizations including the University of Saskatchewan, University of Regina, and Polytechnic Institutes. Joseph holds a Bachelor of Education degree from the University of Saskatchewan.

Robert Martz, Partner, Burnet Duckworth & Palmer LLP (BA'01, JD'10)

Rob Martz is from Saskatoon and graduated from the University of Saskatchewan College of Law in 2010. After law school, Rob clerked for the Honourable Chief Justice Richards at the Saskatchewan Court of Appeal and the Honourable Justice Rothstein at the Supreme Court.

He practices in the areas of commercial litigation and anti-corruption at Burnet, Duckworth & Palmer LLP in Calgary. Rob recently appeared for a group of Alberta craft brewers at the Supreme Court of Canada on *R. v. Comeau* (or the “free the beer case”).

Rob is married to Adrienne Roy who is also a law graduate from USask and is the father to two boys and a girl.

The Honourable Chief Justice Robert G. Richards, Court of Appeal for Saskatchewan (BComm'75, LLB'79)

The Honourable Chief Justice Robert G. Richards was appointed Chief Justice of the Court of Appeal for Saskatchewan on June 30, 2013. He was appointed to the Court of Appeal in 2004.

Chief Justice Richards completed a Bachelor of Laws from the University of Saskatchewan in 1979 and a Master of Laws from Harvard University in 1982. He was a Law Clerk, Supreme Court of Canada (1979-1980); Parliamentary Intern, House of Commons, Ottawa (1980-1981); associate lawyer with Gowling and Henderson, Ottawa (1982-1984); Chief of Staff to the Rt. Hon. Ramon Hnatyshyn, Ottawa (1984-1985); Director of Constitutional Law, Saskatchewan Department of Justice, Regina (1985-1990); and a partner at MacPherson Leslie and Tyerman (1990-2004). He appeared as counsel in over 40 Supreme Court of Canada appeals.

Chief Justice Richards has been the Chair, Supreme Court of Canada – Canadian Bar Association Liaison Committee; Co-chair national Canadian Bar Association Constitutional and Human Rights Law section;

Vice-chair and Council member of the International Commission of Jurists (Canadian Section); and a Director of the Canadian Institute for Advanced Legal Studies. He is a long-time lecturer and presenter at the College of Law, University of Saskatchewan and the Johnson Shoyama Graduate School of Public Policy, University of Regina.

The Honourable Chief Justice Martel D. Popescul, Court of Queen's Bench for Saskatchewan (BA'76, LLB'79)

Chief Justice Popescul obtained a BA from the University of Regina in 1976 and an LLB from the University of Saskatchewan in 1979. He was called to the Saskatchewan Bar in 1980. He was appointed Queen's Counsel (Canada) in 1992 and Queen's Counsel (Saskatchewan) in 2000. He served as a Bencher of the Law Society of Saskatchewan from 1998 to 2003 and was President in 2001. Chief Justice Popescul has frequently presented at legal education seminars and workshops. He was the recipient of the Saskatchewan Legal Education Society Inc.'s (SKLESI) Outstanding Volunteer Award (North) in 2005 and SKLESI's Award of Excellence for Legal Education Development in 2008. Chief Justice Popescul was appointed to the Court of Queen's Bench in 2006 and was appointed Chief Justice of that Court in 2012.

The Honourable Chief Judge, Shannon I. Metivier (LLB'82)

Chief Judge Metivier received her LLB from the University of Saskatchewan in 1992 and was called to the Saskatchewan Bar in 1993. She practiced law as an associate and then as a partner at McKercher LLP in Saskatoon. While in private practice, she was a civil litigator with a wide-ranging practice and actively involved in law firm administration.

She was appointed to the Provincial Court of Saskatchewan on April 18, 2013.

On March 1, 2021 she became the Chief Judge of the Provincial Court of Saskatchewan. She has a special interest in the intersection of mental health and the justice system and currently serves as Chairperson of the Saskatchewan Review Board.

Ms. Foluke Laosebkan, Benchler, Law Society of Saskatchewan (LLB'93)

Foluke Laosebikan obtained a Law degree LLB (hons) from Obafemi Awolowo University (OAU), Ile-Ife, Nigeria in 1993. She also has a Master's degree in Law (LLM) as well as a doctorate (PhD) in Law from Howard College, University of Kwazulu-Natal, Durban, South Africa.

She is trained in Mediation, Collaborative Practice as well as Facilitation. Foluke has a keen interest in Dispute Resolution, Family Law and Public Legal Education. She is the founding director of WeCollaborate-Professionals Promoting Change Through Knowledge Inc. (founded in 2012), as well as the founding director of the programs: Collaborative Law Initiative in Africa (CLIA) and Collaborative Law Initiative in the Northeast (CLIN). She is a past director of Collaborative Professionals of Saskatchewan Inc. (CPSI), having served as a Director on the CPSI Board for seven years.

Foluke is an active member of the Law Society of Saskatchewan and a member of a few other professional organizations including the Canadian Bar Association, Canadian Institute for the Administration of Justice, the Public Legal Education Association of Saskatchewan and Conflict Resolution Saskatchewan Inc.

She brings over 25 years of international legal knowledge and experience.

Dr. Airini, Provost and VP Academic, University of Saskatchewan

Airini earned a BA in religious studies and a Master of Education from the University of Canterbury, an MBA from Massey University, and a PhD in Curriculum and Instruction from the University of British Columbia. She has credentials as a trained teacher and learning the Indigenous language of NZ during two years of night classes.

Airini joined the USask in February 2021 and holds a professorial appointment in the College of Education. Her three-decade career is defined by her leadership internationally and domestically in areas of equity in higher education, Indigenous advancement, and converting research and

policy into improved education outcomes.

Airini has more than 20 years experience in senior academic administration at world-class universities internationally. Airini holds academic appointments in three countries – Australia, Canada, and New Zealand (NZ).

She has led education strategic planning in developing countries, with government budget value of \$97.4 million. She currently advises the UN Food and Agriculture Organization.

A Fulbright Scholar, Airini's research looks at how education success for all can mean all. Airini's research and development initiatives have directly shaped 21st century education systems to close gaps in education success at school and post-secondary levels.

She is the author/co-author of more than 100 research articles, books, and reviewed papers and reports. Airini is a member of the Royal Society of New Zealand.

Dr Airini is a national representative in two sports, a multisport eventer, and is one of only 40 selected from around the world to race The Yukon 1000 – the world's longest canoe race from Whitehorse to Alaska, paddling 1000 miles in nine days or less, on the Yukon river.

John M. Williams, (BA(Hons)LLB) President, Saskatchewan Trial Lawyers Association

Born and raised in Moose Jaw, John attended St. Thomas More College at the University of Saskatchewan, where he completed the Honours Program in Political Science before moving on to obtain his Law Degree.

He articulated to the Chief Justice of Saskatchewan, the Honourable E.D. Bayda. Upon admission to the Bar in 1984 John entered private practice with a predecessor firm and became a founding partner of Gerrand Rath Johnson in 1997.

Outside of law, John has many interests, which include singing and performing with various music groups. He has co-written, produced and performed in several local musical revues raising funds for charitable causes.

In 2020, Prema was named one of the Women’s Executive Network’s Top 100 Most Powerful Women in Canada, receiving the CIBC Executive Leaders Award for leading a multidisciplinary legal team at the forefront of the business and corporate commercial world.

She has been repeatedly honoured for legal career achievements, and currently recognized by Chambers Canada as one of Canada’s Leading Lawyers for Business (Investment Funds), by The Canadian Legal Lexpert Directory for expertise in investment funds and asset management, and by Best Lawyers in Canada in the Mutual Funds Law and Securities Law categories.

Prema is a native of Saskatoon, and is proud to be a University of Saskatchewan graduate, having received both her LLB and B.Comm, with distinction.
