## **SPEAKERS**

#### Joseph Naytowhow (BEd'95)

Joseph Naytowhow is an award-winning Plains/Woodland Nehiyaw (Cree) Interdisciplinary artist from the Sturgeon Lake First Nation Band in Saskatchewan. His generosity and compassion for sharing cultural knowledge make him a much sought after speaker, performer, facilitator, and outdoor educator for adults and children alike locally, regionally, and internationally. A longtime resident of Saskatoon, he has been playing music and telling stories, both tall and short, for over 35 years.

Joseph Naytowhow has served as a cultural advisor to various institutions such as the Indian Teacher Education Program (ITEP) in Saskatoon, and multiple universities across Turtle Island. Joseph holds a Bachelor of Education degree from the Indian Teacher Education Program, University of Saskatchewan. He is pleased to share his creative life experience, coyote trickster tendencies, and cultural knowledge when invited to do so.

#### Michael Milani, KC (LLB'80)

Michael Milani, KC received his LLB in 1980 from the University of Saskatchewan. He is the Chair of the Executive Committee of McDougall Gauley LLP, one of Saskatchewan's largest law firms. He is a past-President of the Law Society of Saskatchewan, which is the organization that governs lawyers, in the public interest. He is a past-President of the Federation of Law Societies of Canada, which is the umbrella organization of Canadian law societies governing Canada's 130,000 lawyers and notaries. Mike is the Chair of the Law Reform Commission of Saskatchewan. He is a Fellow of the Insolvency Institute of Canada, and a Fellow of the American College of Mortgage Attorneys. He has appeared in the Courts of Saskatchewan, Alberta and Manitoba, and in the Supreme Court of Canada. During the 2022 fall term,

Mike was the Estey Chair in Business Law, at the College of Law, University of Saskatchewan.

#### The Honourable Madam Justice Georgina R. Jackson (BA'73, LLB'76)

The Honourable Georgina R. Jackson was appointed to the Court of Appeal for Saskatchewan in 1991. She received her Bachelor of Arts from the University of Saskatchewan in 1973, her Bachelor of Laws from the University of Saskatchewan in 1976 and a Queen's Counsel designation in 1991. Before joining the Court, she was a partner with MacPherson, Leslie and Tyerman, having previously served with the provincial Department of Justice, first as a lawyer in the Civil Law Branch and then as the Master of Titles.

Her extrajudicial activities have focused on law reform and supporting continuing education in some form. She is a past-President of the Canadian Institute for the Administration of Justice and a past associate judicial director with the National Judicial Institute. Over the years, she has organized and chaired numerous seminars for judges and lawyers for those and other organizations. She has held a variety of board positions, including being the first woman to have served as President of the Uniform Law Conference of Canada and of the Saskatchewan Branch of the Canadian Bar Association. Justice Jackson has spoken and taught in many countries, including Germany, Italy, France, Israel, the Philippines, Turkey, and Japan, primarily with respect to judicial ethics.

#### The Honourable Madam Justice Natasha Crooks (JD'04)

Justice Crooks received a Bachelor of Arts in Economics from the University of Regina in 1999 and a Juris Doctor with Distinction from the University of Saskatchewan in 2004. She articled at the Department of Justice Canada and began her law career in the area of civil litigation.

Justice Crooks was appointed to the Parole Board of Canada in 2013 and served as a

Board Member until March 2018. During that time, she was a member of the Parole Board of Canada's Executive Committee and Chairperson of the Indigenous Circle, a national committee of the Parole Board of Canada that provides advice on issues that impact Indigenous offenders, victims and communities. Justice Crooks was appointed to the Provincial Court of Saskatchewan in March 2018 and to the Court of King's Bench for Saskatchewan in May 2019.

#### Andrea Argue, KC (LLB'01)

Andrea Argue, KC obtained her LLB with Great Distinction from the University of Saskatchewan in 2001. She then served articles of clerkship to Bayda C.J.S. and Sherstobitoff J.A., as they then were, of the Court of Appeal for Saskatchewan.

After admission to the Law Society of Saskatchewan in 2002, Andrea began her legal career in private practice in Swift Current. She remains in private practice in Swift Current, now as a partner with Kanuka Thuringer LLP. Her practice areas, often with an agricultural focus, include corporate and commercial law, real estate, business organization, and succession, estate planning and estate administration.

Andrea currently holds the position of President at the Law Society of Saskatchewan. She actively volunteers as a presenter on various professional topics and has been a dedicated Bencher, serving on multiple committees within the Law Society of Saskatchewan since 2019. In addition, she serves as the Chairperson of the Swift Current Comprehensive High School Community Council.

#### Dr. Airini, Provost and VP Academic

Dr. Airini began her term as the Provost and VP Academic at the University of Saskatchewan on February 1, 2021. Dr. Airini works with academic leadership within our complex and globally engaged research institution to support our commitment to being the university the world needs.

A highly accomplished researcher, educator and administrator, Dr. Airini's research explores how education can help build a more equitable society for all. Her award-winning research and development initiatives in Canada and internationally have directly shaped universities and 21st-century education systems to close achievement gaps at school and postsecondary levels.

#### The Honourable Justice April D. Grosse (BA'94, LLB'97)

Justice Grosse grew up in North Battleford, Saskatchewan. Prior to attending law school, Justice Grosse studied French at the University of Saskatchewan and l'Université du Québec à Chicoutimi. After graduating from the University of Saskatchewan, College of Law in 1997, Justice Grosse served as law clerk to the Honourable Justice John Sopinka and the Honourable Justice Ian Binnie at the Supreme Court of Canada. In 1998, she joined Bennett Jones LLP in Calgary, where she became a partner in 2006 and a member of the firm's Board of Directors in 2015. Justice Grosse maintained a diverse litigation practice, with particular experience in commercial, estates, policing and administrative law matters.

In May 2018, Justice Grosse was appointed to what was then the Alberta Court of Queen's Bench, where she heard cases in all areas under the Court's jurisdiction, co-chaired the Information Management and Technology Committee, was a member of the French Language and Interpretation Steering Committee, and served on the Family Resolution and Commercial Duty rosters. Justice Grosse was appointed to the Court of Appeal of Alberta in April 2023. As a member of the Court of Appeal of Alberta, Justice Grosse also serves on the Northwest Territories Court of Appeal and the Nunuvut Court of Appeal. She hears cases in both English and French.

Justice Grosse has been involved in

a variety of legal and community organizations, including the Calgary Bar Association, the Supreme Court Advocacy Institute, the Centre for Professional Legal Education and the Scarboro Community Association. She is a regular judge at the national Laskin Moot Court Competition.

#### The Honourable Madam Justice Mona L. Dovell (LLB'83)

Justice Dovell graduated from the University of Saskatchewan, College of Law in 1983 and was called to the Saskatchewan Bar in 1984. She was a partner at the law firm of Halyk and Allbright practicing both criminal and civil litigation and was President of the Saskatchewan Trial Lawyers Association before being appointed to the Court of King's Bench for Saskatchewan in 1997. As a member of the Court for the past twenty-six years, ten of those years she has spent as the Chair of the Criminal Practice Committee.
